BEFORE SIGNING PLEASE READ TERMS OF CONTRACT ON REVERSE OF THIS FORM

TERMS OF CONTRACT

1. **BOOKING DEPOSIT.** A booking deposit is charged on signing this contract. This fee is NOT refundable.
2. **PAYMENT.** Payment of the balance of the agreed fee must be made on the day of the event.
3. **COPYRIGHT.** By signing of this contract, the client assigns to the Videographer the copyright of all video material specified in the schedule. The Videographer may use extracts from this for commercial purposes.
4. **ARTISTIC LICENCE.** The Videographer shall be granted artistic licence by the client, in relation to the material and locations used, and the Videographer's judgement regarding locations shall be deemed correct unless previously discussed and agreed with the client PRIOR to the event.
5. **SOLE RIGHTS.** The Videographer shall be the sole professional videographers at the venue specified. No objections is raised to family Videographers operating at the event, providing due priority is given to the professional Videographer to ensure satisfactory discharge of this contract.
6. **FORCE MAJEURE.** The due performance of this contract is subject to alteration or cancellation by the Videographer owing to ANY cause beyond their control. In the event of failure of the video equipment or ancillary accessories, or cancellation of this contract by the Videographer, liability shall be LIMITED TO A FULL AND COMPLETE REFUND OF ALL MONIES PAID.
7. **CANCELLATION OF CONTRACT.** The client may cancel the contract at any time prior to the event by giving WRITTEN notice to the Videographer. However, the amount paid as deposit shall be retained by the Videographer as compensation against loss.
8. **COMPLAINTS PROCEDURE.** In the unlikely event of a dispute over the supply of product(s) or service(s), the Client and Company agree to accept the findings of the Institute of Videography's Arbitration Office. Any disputes must be notified within 28-days of the Client receiving the product(s) or service(s).
